

# Nayutal App End User License Agreement

NAYUTAL LICENSES THIS PROGRAM, TOOL, PLUG-IN, ADD-ON, TECHNICAL ADD-ON, APPLICATION, SOLUTION, LIBRARY, CONTENT, DATA, EXAMPLE MODULE, FILES, COMMAND, SERVICE OR OTHER ITEM OR MATERIAL (THE "**APP**") TO YOU ONLY UPON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS END USER LICENSE AGREEMENT ("**AGREEMENT**"). IF YOU DO NOT AGREE TO THESE TERMS,

The apps made available are licensed, not sold, to you. You agree that the terms of this Agreement will apply to each App that you license.

**License.** Subject to the terms and conditions of this Agreement, Nayutal grants to you non-exclusive, non-transferable, non-sublicensable license to download and use the App for your internal business purposes and only in connection with the specific Nayutal software product or web-based or hosted service identified in materials distributed with the App, with which such App was designed to operate ("Nayutal Software"). Therefore, you may use the App only if you are an authorized licensee or customer of the Nayutal Software and for the term and within the scope of the license granted for the Nayutal Software. This Agreement does not modify or alter the terms of the software license agreement or terms of service delivered with the Nayutal Software. Nayutal and its licensor(s) own all rights and interests to the App, including all intellectual property rights related thereto.

**Additional Rights and Restrictions.** You may copy, modify and redistribute the App or any portions thereof, subject to your compliance with the terms and conditions of this Agreement and particularly the following restrictions: (a) you must distribute the App only as part of an extension, add-on, plug-in, example module, configuration files, function or application developed by you ("Extension") and solely for the purpose of running your Extension in connection with the Nayutal Software; (b) any proprietary legends or notices contained in or on the App or any portions thereof cannot be removed or altered; (c) you must comply with any restrictions or requirements for the third-party software (including any open source libraries) included in the App or any portions thereof; (d) you must give appropriate credit to Nayutal and indicate if any changes were made to the App in the Extension; (e) you do not make any statement that the Extension is certified or that its performance is guaranteed by Nayutal; and (f) you agree to defend and indemnify Nayutal and its licensors from and against any damages, costs, liabilities, settlement amounts and/or expenses (including attorneys' fees) incurred in connection with any claim, lawsuit or action by any third party that arises or results from the use or distribution of the Extension, unless such claim, lawsuit or action arose or resulted directly and solely from Nayutal Software or the App itself as originally provided to you by Nayutal.

NAYUTAL SPECIFICALLY DOES NOT WARRANT THAT THE APP WILL MEET YOUR REQUIREMENTS; WILL OPERATE IN ALL THE COMBINATIONS WHICH MAY BE SELECTED FOR USE BY YOU; THAT THE OPERATION OF THE APP WILL BE ERROR-FREE OR UNINTERRUPTED, ACCURATE, USEFUL, RELIABLE, OR COMPLETE; OR THAT ALL ERRORS OR DEFECTS IN THE APP WILL BE CORRECTED.
